A Note To Readers

The California Water Management System, since the building of the Central Valley Project, was the largest and most complex such system in the world. Today, China is building a nation-wide water management system, much larger and more complex than that of California, yet ours is still something to marvel.

Over the past few weeks, as I have documented in these reports, that system is now coming apart. Even a new report commissioned by the Westlands Water District make this point: "The Central Valley Project is broken, the management of state water resources is jeopardizing the region, and without a solution there is little hope of a turnaround that will improve conditions for farming in 2017."

The drought has just provided the moment of opportunity for this to strike now. Having abandoned the idea that the government is responsible to create that which will be required by one or two generations in the future, the state has built next to nothing in water infrastructure over the past 40 years. Having turned the U.S. into a gambling casino of Wall Street speculation, the American Society of Civil Engineers now reports that our general infrastructure deficit totals trillions of dollars.

Then there is, accompanying the economic insanity, the adoption of a cultural revolution (sort of like China's Cultural Revolution of the 1960s) called "environmentalism," that openly rejects the idea that Mankind is created in the image of The Creator-- that the creative powers of each human being makes mankind capable of transforming, for his well-being and for his future, the universe in which we live. Or, as the great space scientist Kraaft Ehricke put it, "Nobody and nothing under the natural laws of this universe impose any limitations on man, except man himself."

Thus, as I have said again and again for the more than two years I have been writing this weekly report, there is no solution to the water crisis we now endure either within the state of California, nor within the present bankrupt financial-monetary system.

This week's report, in order to make this last point even more clear, shall concentrate on that topic and the real solution. The first two sections below provide the necessary policy overview. Following that will be examples of how we used to think; the kind of thinking that built the Central Valley Project and the State Water Project. Then, the next section highlights the projects that did not get built-- projects that the Kennedy administration actually had taken the initiating steps to build. The following section focuses on understanding how to think about water policy. Finally we present some links on the historical background of the California water management system.

The Trans-Atlantic banking financial system is now in the process of collapse, a collapse that will be more destructive than that of 2008, unless the first item below becomes the policy of the United States.

The first job in reconstructing anything is to take the garbage out. To do so requires, first, reestablishing the Glass-Steagall banking law, established by Franklin D. Roosevelt in 1933 and abandoned by the Congress and the President in 1999.

The First Step

What is needed, first and foremost, is a passionate commitment to the future of the human species. That means economics as Lyndon LaRouche has long defined it: increasing man's dominance over nature through the power of creative discovery of universal physical principles. "When we are inclined to take these wonders for granted, let us remember that only a generation or two ago all the great rivers of America, the Missouri, the Columbia, the Mississippi, the Tennessee, ran to the sea unharnessed and unchecked. Their power potential was wasted. Their economic benefits were sparse. And their flooding caused an appalling destruction of life and of property. Then the vision of Theodore Roosevelt was fulfilled by Franklin Roosevelt, and to demonstrate how important this is as a national issue, two distinguished American Presidents from New York State saw how essential it was to the Nation and New York State to develop the resources of the West. What Was Not Built

Two projects underway at the time of the assassination of President John Kennedy, limped along for a few years, but were abandoned in the following years as the U.S. changed. We went to war in Vietnam, shifted the economy to speculation, and the first plague of environmentalism began.

The Presidents who gave us environmentalism

As I have stressed repeatedly in my weekly *California Drought Updates* the disaster we now experience in this water crisis originated after the death of President John Kennedy. The nation, once an industrial, scientific, infrastructure and production oriented economy was taken over by Wall Street speculators and turned into a gambling casino. Accompanying that shift was the appropriate ideology of environmentalism.

The usual narrative that the environmentalist control over the state is a solely Democratic responsibility is just not true. The following from "The Central Valley Project – Introduction," by Eric A. "The 1960s marked the end of the era of large dam building, and caught the CVP in a political and economic whirlpool with no apparent end. Environmental concerns began cropping up in the 1970s. President Richard M. Nixon signed the Endangered Species Act in 1973. The Act set criteria for listing endangered species and protecting them from harm by federal agencies or private concerns. The Central Valley Project felt the consequences of the Endangered Species Act because of Project features' impacts on migratory salmon.

"The Central Valley Project Improvement Act of 1992 (CVPIA) started the CVP in a new direction. President George Bush signed the bill as part of the Reclamation Projects Authorization and Adjustment Act of 1992, over the objections of California Governor Pete Wilson and Central Valley legislators. Environmentalists considered the act a victory, while California agricultural leaders considered it a disaster. The CVPIA reallocated 800,000 acre- feet of CVP water (600,000 in dry years) from Valley farmers toward the restoration of Central Valley fisheries. CVPIA limited renewed agricultural water contracts to twenty-five years with no long-term renewals. The Central Valley Project Improvement Act opened a new political pandora's box in California."
